Dear Sir,

We appreciate Earthsight for it's environmental concern, for bringing the issues within your letter dated 7th June 2021 to our attention and for the opportunity to provide a written response. PT Karya Sutarindo (KS) is a manufacturer within the furniture industry. We are always committed to environmental protection, sustainable production and social accountability throughout our business operations.

We work diligently to be compliant with laws, regulations and policies. In accordance with these principles, KS fully complies to the national, international forestry laws and internal company codes. KS has always complied with the requirement of the mandatory scheme of Timber Legality Assurance System (*Sistem Verifikasi Legalitas Kayu (SVLK)*) and FSC Certification in sourcing and importation of materials.

We can confirm that we are a supplier to IKEA, producing a number of articles including the ones you mentioned. However, for the articles you have mentioned, the LATT table, MÅLA easel, we do not source wood from the region you speculated. Therefore, it is reasonable and fair that we request Earthsight to omit those unrelated articles from the report.

We can confirm that we are a supplier to Pottery Barn/Williams Sonoma and Target. However, Pottery Barn/William Sonoma's ranges of furniture and Target's ranges of furniture, we do not source wood from the region you speculated. Therefore, it is reasonable and fair that we request Earthsight to omit those unrelated parties from the report.

We are investigating the allegations in your letter and will share no further information at this time. KS will continue to insist on procuring legally sourced wood for use in our manufacturing process.
